# Kāinga Ora – Homes and Communities releases bond and bill tender schedules for the second half of FY2021/22.

Volume and frequency remain unchanged for bond tenders at up to \$100 million per tender. However, we are adding flexibility to our fortnightly bill tenders regarding volume and tenor, when required.

#### **Bond Tenders**

Monthly bond tenders, operated through the Yieldbroker Auction System with approved Primary Dealers, are expected to account for around half the annual issuance. Each bond tender will be up to \$100 million in volume. Kāinga Ora reserves the right to alter the composition, postpone or cancel a bond tender at any time.

Kāinga Ora will now announce the volume and tenor/s of bills to be tendered one business day prior to the tender date. We will continue to offer a minimum \$25 million per tender, however subject to market conditions may offer higher volume and for maturities of up to 12 months. Bill tenders are operated through the Yieldbroker Auction System.
