I write in response to your request dated 13 June 2024, for information under the Official Information Act (1982):

'please provide a breakdown of the number of properties in the lease portfolio from 2020-2021 to present day each year, each region. both for properties leased out by and leased to KO.

provide cost of mtce to KO of leasing to and from stakeholders, per region.

provide cost of repairs undertaken at properties at hand back/end of each lease to date. provide per region number of KO owned properties vacated each year from 2020-2021 to present day and cost of reinstating vacated properties to lettable condition, per region per financial year.

provide regional and yearly breakdown of any major repairs undertaken (above \$15k per workorder) at KO owned properties while tenanted, for abovementioned time period.'

Kāinga Ora has considered your request under the Act. Responses to each of your questions, with notes for context, are provided in the order you requested them.

Where your request relates to leases, this has been interpreted as information about properties in the Kāinga Ora lease portfolio. Information held on properties in the lease portfolio that relates to your request above are:

- Leased 'out by' Kāinga Ora:
 - properties owned by Kāinga Ora and leased out to service providers for the purpose of Transitional Housing
- Leased 'to' Kāinga Ora:
 - properties leased from private owners to Kāinga Ora under the Home Lease Programme

The maintenance costs provided include both responsive maintenance (responding to maintenance issues as needs arise throughout the course of the lease) and planned maintenance (maintenance we schedule ahead of time to preserve the condition of the property, for example exterior painting, or roof replacement when needed). Significant weather events in recent years also generated clean-up work which is costed as maintenance.

When comparing maintenance activity and spend across the four years it is also important to keep in mind that comparatively less maintenance work was caried out during the COVID pandemic and subsequent lockdowns which prevented access, and our maintenance partners caught up on this work in the later financial years. Secondly, across the sector all property owners have experienced



increases in the cost of materials for building and maintenance, and Kāinga Ora has not been immune to these changes.

- cost of maintenance and repairs to the interior of the home and the exterior grounds of the property. In accordance with the lease agreement, this work is arranged by Kāinga Ora and costs are covered by Kāinga Ora.
- cost of maintenance and repairs to the exterior of the home and any structural repairs required through the course of the lease, and any work to meet Healthy Homes Standards. In accordance with the lease agreement, this work is arranged by Kāinga Ora and, depending on the work, costs can either be initially paid by Kāinga Ora then recovered from the private owner, or paid directly by the owner.
- the costs in this table represent 49,455 individual work orders and 1.59% of our total maintenance spend across the entire Kāinga Ora housing portfolio over the four financial years.
- this table does not include any costs recovered from private owners for Healthy Homes work. Over the last four financial years, a total of \$4,732,166.39 has been paid back to Kāinga Ora by private owners for this work. Due to the way this is recorded in our centralised systems, we are not able to provide a breakdown by region.

- the costs in this table represent 30,785 individual work orders and 0.64% of our total maintenance spend across the entire Kāinga Ora housing portfolio over the four financial years.

- in accordance with the lease agreement, Kāinga Ora has a legal obligation to return the property to the private owner in the same state it was at the commencement of the lease, less fair wear and tear and ageing. Maintenance costs reflect this work.
- lease agreements have a term of three years and owners have the option of either extending the lease or taking their property back at the end of the lease period. The higher costs in FY24 reflect that more leases expired and those properties were handed back that year. Comparatively lower costs in FY21 can also be attributed to fewer properties handed back during the COVID pandemic and resulting lockdowns.
- the costs in this table represents 1,216 individual work orders and 0.24% of our total maintenance spend across the entire Kāinga Ora housing portfolio over the four financial years.
