Purpose

 This memo provides you with information and options for how to proceed with the Hutt City Council (the Council) Infrastructure Acceleration Fund (IAF) funding agreement regarding a request for variation to reallocate a portion of existing IAF funding to address the funding gap for delivery of the City Link Bridge that provides pedestrian access to the new Melling train station.

Executive summary

- 2. In October 2022, Kāinga Ora, as agent of the Crown, and Hutt City Council (the Council) entered an IAF funding agreement for \$98.9 million of funding for the stormwater solution that supports intensification of Lower Hutt city centre to enable over 3,500 dwellings. The stormwater solution will be delivered alongside the Te Awa Kairangi ("RiverLink") projects which are being delivered between the Council, Greater Wellington Regional Council and the New Zealand Transport Agency (NZTA).
- 3. The original IAF application presented the RiverLink project investment as a key catalyst to enable the housing intensification of Lower Hutt. One of the key components of the project is a new City Link Bridge connecting a revitalised city centre to a new, relocated Melling Train Station. In the Hutt City Council 2024-34 Long Term Plan, the City Link Bridge project was budgeted to cost \$55 million with the assumption that Council would receive a 51 percent Funding Assistance Rate (FAR) subsidy from NZTA.
- 4. Since then, the Government Policy Statement on Land Transport has been amended which has meant the City Link Bridge is no longer eligible for funding from NZTA. As a result, there is now a deficit of around \$28 million in the funding stack to complete the bridge.
- 5. Since entering into the IAF funding agreement, the Council has completed the feasibility investigations and identified that a more efficient stormwater solution (singular pipe rather than two separate) could be implemented that would enable the same housing outcomes at a reduced cost of \$107 million (P95). Based on the updated costs of the new stormwater solution, IAF funding has reduced to \$72 million, with the balance of the total funding (approximately \$26.9 million) remaining available to the Council to address genuine cost increases, should they arise throughout delivery of the project.
- 6. As a mitigation to the deficit in the funding stack for the City Link Bridge, the Council has formally requested that the 'savings' from the stormwater solution be transferred in the IAF funding agreement to the City Link Bridge. The IAF team has assessed this request for variation and considers it to be a reasonable solution to ensure that outcomes are achieved on the accelerated timeframe.

Background

- 7. In October 2022, Kāinga Ora, as agent of the Crown, and the Council entered an IAF funding agreement for \$98.9 million to support delivery of a stormwater solution that will enable an additional 3,500 dwellings in Lower Hutt's central city.
- 8. Te Awa Kairangi (RiverLink) is an urban revitalisation programme to support intensification in the city centre of Lower Hutt involving significant river restoration and flood protection works, improved walking and cycling routes, and access to public transport. These projects are critical for encouraging economic growth in the city and attract both commercial and residential development.
- 9. The RiverLink projects are being delivered by the Council, Greater Wellington Regional Council and NZTA. While the IAF is not a part of this partnership, the IAF funding agreement requires the Council to use reasonable endeavours to ensure delivery of all related infrastructure projects necessary to enable dwellings.
- 10. One of the non-IAF funded infrastructure projects is a new City Link Bridge connecting the revitalised city centre to the relocated Melling Train Station. At the time of entering IAF agreements, it was expected that Council would receive a FAR subsidy from NZTA for delivery of the bridge, however, due to changes in the Government Policy Statement for Land Transport, this project is no longer eligible for funding, leaving a shortfall of circa \$28 million based on current cost estimates.

Discussion

Approach to variation requests

- 11. The purpose of the IAF is to support local councils to deliver infrastructure solutions that will enable housing in areas of high demand. At the time of entering IAF funding agreements, most of the infrastructure solutions and housing developments were at the concept phase. As such, it was always expected that funding agreements would need to be updated and varied as design works advanced, and timing and cost became more certain. While some IAF agreements have anticipated points in time to update these details and associated milestones, there are also points in time where unforeseen circumstances arise and must be addressed in order to proceed.
- 12. In such cases, funding recipients may submit a request for variation to be considered by the IAF team, acting reasonably and in good faith. In line with Government priorities, the IAF team has adopted an operating approach whereby requests will be accommodated if there are reasonable grounds to believe that they are necessary to maintain the objectives of the IAF, do not put Crown funds at undue risk, and allow the housing outcomes to be achieved in line with the accelerated timeframe.
- 13. When the request involves a material scope change¹, this decision is escalated to Joint Ministers.

Updates to the IAF-funded Stormwater Solution

14. The original IAF funding agreement, signed in October 2022, included two stormwater pipelines and associated pump stations for a total cost of \$135.5 million, of which \$98.9 million

¹ The definition of "material" has not been formally agreed. HUD is responsible for development of a Change Control Framework to outline specific thresholds for what is considered to be a "material" scope change.

would come from IAF-funding and \$36.6 million of co-funding from Council. Through the stage 1 feasibility investigation, it was identified that a more efficient stormwater solution could be implemented that would enable the same housing outcomes at a reduced total cost of \$107 million (P95).

- 15. A Delivery Plan was agreed at the commencement of stage 2 (detailed design, consenting, land acquisition, etc.) to recognise the updated solution. Based on updated costs of the new stormwater solution, IAF funding reduced from \$98.9 million to \$72 million. As per terms of the agreement, the balance of the total funding (around \$26.9 million) remains available to address genuine cost increases, should they arise throughout delivery of the project.
- 16. The inclusion of this term in IAF funding agreements is in acknowledgement of the full package of works required to enable dwellings and can be transferred between IAF funded projects if one project experiences cost savings and another experiences cost increases. In this case, there is only one IAF-funded project, so the balance remains to address cost increases for the stormwater project alone. Any unutilised funding at project completion (estimated to be in 2029) will be returned to the centre.

City Link Bridge – pedestrian access to Melling Station

- 17. One of the non-IAF funded enabling infrastructure projects acknowledged in the IAF funding agreement is a new City Link Bridge connecting the city centre to the relocated Melling Train Station.
- 18. In the Hutt City Council 2024-34 Long Term Plan, the City Link Bridge project was budgeted to cost \$55 million with the assumption that council would receive a 51 percent FAR subsidy from NZTA. However, due to changes in the Government Policy Statement for Land Transport, the bridge is no longer eligible for the FAR subsidy, leaving a shortfall of circa \$28 million based on current costs.

Variation Request from Council

- 19. Hutt City Council have submitted a formal request to the IAF team to vary the IAF funding agreement to reallocate the excess \$26.9 million of IAF funding from the revised stormwater solution to the City Link Bridge.
- 20. The total cost for the City Link Bridge is currently estimated at \$55 million, for which Council would be required to fund \$28.1 million and bear all cost risk for any potential, future cost increases on IAF-funded (and non-funded) projects.

Options for moving forward

- 21. The IAF has assessed the request and given the materiality of the variation to the funding agreement, is seeking joint Ministers' decision on how to proceed.
- 22. While there may be other options that could be explored in terms of an alternative solution, this would be cost, time and resource intensive for both the Council and the IAF team. Given that the request for variation from the Council is for a specific solution, we consider that there are two options for Ministers:

- Option 1: Status quo this option would mean the existing IAF Agreement would remain as is and continue to support the delivery of the stormwater solution only. The Council will continue to have an obligation to use their reasonable endeavours to ensure that all of the related enabling infrastructure projects (including the City Link Bridge) are completed on an accelerated timeframe to achieve the housing outcomes.
- ii) Option 2: Re-allocate approximately \$27 million of IAF funding from the stormwater project to the City Link Bridge. This option would fully leverage IAF funding across both projects with Council responsible for co-funding and any potential cost increases.

The benefits and risks of both options are included here:

Benefits	Risks
 Potential for IAF funding to be returned to the centre once the stormwater project is complete in 2029. Approximately \$27 million is held as contingency for genuine cost increases on the stormwater project. 	 The City Link Bridge will not be delivered (at least in the near term) and the connection between the Lower Hutt city centre and Melling train station will be severely impacted. Greater Wellington Regional Council have publicly stated that if the City Link Bridge is not delivered, there is little point in keeping the Melling Train Line open. Closure of the line would seriously impact connectivity between Lower Hutt and Wellington City. Without the City Link Bridge to the new rail station, the attractiveness of planned residential and commercial development in Hutt City may be compromised, resulting in lower demand and slower housing delivery in the area. The IAF housing outcomes will be unlikely to be delivered within the timeframes anticipated by the Council when the IAF agreements were signed, thus slowing any acceleration of housing outcomes.

Option 2: Approve transfer of existing IAF funding within the RiverLink Funding Agreement from the Stormwater Pipeline Project to the City Link Bridge Project

Reduce the maximum IAF funding for the Stormwater Pipeline project from \$98.9 million to \$72 million and reallocate the remaining \$26.9 million of IAF funding to the City Link Bridge project, which is listed in the IAF Funding Agreement as a Related Enabling Infrastructure Project (Non-IAF funded), for Hutt City Council to deliver.

Better integration between the city and the Hutt River (Te Awa Kairangi / RiverLink) will improve the attractiveness of the city centre, making it a more liveable city and

supporting urban residential growth.

- 23. Hutt City Council has demonstrated their commitment to achieving the housing outcomes by finding alternative solutions that will be more cost effective yet achieve the same results.
- 24. The Crown is heavily invested in the RiverLink precinct with NZTA still providing a large sum of capital funding (exact sum currently under review) and KiwiRail as key stakeholder in realising the full benefits of the investment.
- 25. While the reallocation of funds across two separate projects may appear to increase risk for the Crown, it is also the exact reason why the IAF exists to help plug the gap between what infrastructure costs and Councils can afford. Over the multi-year planning and design phases

- for large scale infrastructure, unforeseen challenges related to regulation or policy change impacting on funding stacks often occurs and solutions must be found in order to proceed.
- 26. The commitment in the IAF funding agreements is for a capped amount of funding to support the delivery of outcomes. It was not intended to drive decision-making for Councils about the exact type of infrastructure to deliver but rather, provide funding for the solutions Councils have developed, so long as the outcomes committed to are achieved.
- 27. Despite having the IAF funding committed, the Hutt City Council found a more cost-effective solution to deliver the stormwater upgrades. This is what is expected by the IAF team as these projects move through the early stages. As part of the variation request, the Council has reconfirmed their commitment to co-funding and carrying all cost risk associated with delivery.
- 28. Allowing the Council to reallocate the savings created through diligent feasibility assessment to fill a funding gap for the City Link Bridge (due to changes in policy outside of their control) is both reasonable and is the purpose of the fund working in practice.
- 29. The IAF team has assessed the request for variation and acknowledges the effort put in by Hutt City Council to find alternate solutions to honour their commitment to achieving housing outcomes in the central city.
- 30. Kāinga Ora recommends option 2, on the basis that it supports the IAF's core purpose of accelerating infrastructure and housing delivery and considers the request for variation to be a reasonable mitigation for Council to stay on track with the programme in the funding agreement.

Position of the Ministry for Housing and Urban Develop on the variation request

- 31. HUD's view is the funding should not be transferred to the CityLink Bridge because:
 - There is still risk in progressing with the stormwater option and that until the savings are confirmed that it is prudent they stay allocated to the stormwater project. HUD wishes to avoid the situation where two projects without cost and delivery confidence are embedded in the IAF.
 - They understand the value to the wider urban development outcomes of progressing the CityLink Bridge. However, they do not believe that the bridge directly enables housing and has all of the direct benefits stated in the documentation provided.
 - They also have concerns around the cost certainty and the delivery risk, knowing that the RiverLink Alliance has already provided a cost estimate that differs significantly from that forecasted in the documentation. They see no evidence of a significantly de-scoped solution or a cost estimate that comes in at or around the numbers stated that can be delivered as planned. They also note that if the costs come in higher than expected that HCC will have to find the funds to cover this.
 - The funding shortfall arose from GPS 2024 reducing the walking and cycling class thus leading to NZTA not allocating any funding subsidy to this project. Now the funding subsidy is being replaced with IAF funding which may create reputation or precedent risk.

Position of the Treasury on the variation request

- 32. Treasury provided the following commentary:
 - The Treasury was consulted on the matter, and working with HUD, sought further information, a lot of which was only received this week.
 - As a result, the Treasury has been unable to process this information to provide a recommendation in the limited time and resource available and will provide separate advice to Ministers if required.

Next Steps

33. Once a decision has been made by joint Ministers, the IAF team will inform Hutt City Council of the outcome and either (option 1) proceed with the funding agreement as is or (option 2) work with Council on a delivery plan to transfer approximately \$27 million from the stormwater project to the City Link Bridge.

2. Update for Ministers

Update on transfer of KiwiBuild and Infrastructure Acceleration Fund administration

In line with the Turnaround Plan, the Commercial Products team at Kāinga Ora have been working with their colleagues at the Ministry of Housing and Urban Development (HUD) to transfer any residual KiwiBuild underwrite activity. That transfer is now complete, and HUD has assumed full operational responsibility for the administration of the KiwiBuild activity from 1 July 2025.

The transfer included data and files management, operational processes and financial management. In addition, all developers and suppliers involved in the KiwiBuild programme have been advised and introduced to the team at HUD.

In addition, the administration of the Infrastructure Acceleration Fund (IAF) has been successfully transferred from Kāinga Ora to National Infrastructure Funding and Finance (NIFF) with effect from 1 July 2025. The transition period went smoothly, and a full handover of documentation, data, and the reporting software have been provided to the team at NIFF. All funding recipients and developers who have entered into IAF Agreements have been informed.
