Thank you for your email dated 20 November 2023 to Kāinga Ora – Homes and Communities, requesting the following information under the Official Information Act 1982 (the Act):

- 1) What houses have you bought in the past year on the West Coast? Where? What did you pay?
- 2) What sections have you bought, where, and what did you pay?
- 3) Why did you buy them?

I have consulted with relevant staff and provided responses below to each of your questions. As mentioned in our email acknowledging your request, we have interpreted 'sections' to mean sections of land, and West Coast to cover the area of the three Territorial Local Authorities (Buller, Grey, Westland) in the region.

1) What houses have you bought in the past year on the West Coast? Where? What did you pay?

The total cost of the 14 newly built properties was \$7,452,227, while the cost of buying the three existing properties was \$1,410,000.

When considering the acquisition of a property, we balance the cost of purchasing homes with the need to house people and their families in these areas. There is a need for housing on the West Coast and one of the ways we are helping to address this is to buy completed new homes from developers.

2) What (land) sections have you bought, where, and what did you pay?

Kāinga Ora did not purchase any sections of land in any of the three West Coast Territorial Local Authorities (TLAs) from 1 November 2022 to 31 October 2023.

3) Why did you buy them?

The properties in the table above were acquired to help meet the regional need for public housing on the West Coast, which is reported by the Ministry of Social Development's Housing Register (https://www.msd.govt.nz/about-msd-and-our-work/publications-resources/statistics/housing/housing-register.html#LatestresultsSeptember20231):
