Thank you for your email dated 23 April 2025 requesting the following information from Kāinga Ora – Homes and Communities under the Official Information Act 1982 (the Act):

We are a tauranga based manufacturer/supplier of all types of window treatments namely curtains and blinds.

I am wanting to find out the builders that are doing work at all the KO developments from Auckland to Wellington. Some are listed on KO site as to who the builders are but others are not listed online. We are wanting to approach the building companies that we are not presently doing work for to offer our services for window treatments.

Please find included with this response a list of build partners that have worked with Kāinga Ora to deliver social housing across New Zealand, which includes build partners from Auckland to Wellington.

It is important to note that Kāinga Ora contracts for the supply of window treatments via the Government Electronic Tendering Service (GETS). The last open market Request-For-Proposals (RFP) for a three-year supply contract was advertised in November 2024 for a new contract to supply Kāinga Ora, beginning 1 July 2025. Kāinga Ora will be requiring the build partners it works with to use the successful supplier that was awarded this tender.
