Thank you for your email of 22 October 2019 requesting the following information from Kāinga Ora – Homes and Communities, formerly Housing New Zealand, under the Official Information Act 1982 (the Act):

Can I get a breakdown of all properties purchased by the Government for social housing since the coalition Government formed in the [separate] council areas of Tauranga, Western Bay, Rotorua and Taupō.

For each property please provide the address, the date of purchase, the purchase price paid, the reason for the decision to purchase that particular property, and how it is being used.

Please find included with this response, a table containing most of the information you have requested. For privacy reasons, I am declining to provide the street numbers of the houses purchased by Kāinga Ora under section 9(2)(a) of the Act to, 'protect the privacy of natural persons...'

From 26 October 2017 when the current Government was formed, to 30 September 2019, Kāinga Ora purchased 18 properties across the four Territorial Local Authorities you requested, for use as public housing.

Kāinga Ora's preference when seeking to increase its supply of rental housing is to better utilise the land it already owns. However, from time to time, it will make strategic purchases of newly built or existing homes on the market. Kāinga Ora has a number of reasons for buying such properties, including the homes being close to amenities, in areas with a low concentration of state houses, and having a bedroom configuration that is in demand.
