Thank you for your Official Information Act 1982 (OIA) request received 15 September 2021, regarding the proposed housing development on Wood Street, Wainuiomata. My responses to your questions are listed below.

- 1) What actions has Kainga Ora taken between April 2020 and today in regards to this development? Please provide a summary of what meetings have been held with other agencies, contractors, iwi etc and the dates and topics of these, as well as what other actions have been taking place to progress this.
 - a) I can advise that Kāinga Ora Homes and Communities has been meeting with representatives of the Port Nicholson Block Settlement Trust (PNBST) to discuss, amongst other things, options for Wood Street. Other considerations around developing the land at Wood Street, and the final mix of housing have been on hold while these negotiations take place. The meetings have been informal and without minutes. The dates of meetings since April 2020 are:

- 2) What is the forward plan including expected milestones for this development? When will the land be purchased? When will construction start? When is construction intended to be complete by? When will tenants start moving in?
 - a) I am declining this aspect of your request under section 18(g) of the OIA as the information is not held by Kāinga Ora. As previously advised, Kāinga Ora cannot progress this development until it has secured the land. We will provide an update to the community as soon as we have progress to report.
- 3) What are the latest plans for this development? How many houses will there be? Will there be a mix of transitional, permanent state homes and Kiwibuild as repeatedly requested by the community?
 - *a)* I am declining this aspect of your request under section 18(g) of the OIA, per my response to question two.

- 4) What is Kainga Ora's plan for engaging with the local community again to discuss their latest proposal for this site and address community concerns? When will this communication begin? I note there has been a lengthy gap in communications which again is not ideal for building a trusting relationship with the community.
 - *a*) I am declining this aspect of your request under section 18(g) of the OIA per my response to question two.
- 5) Please also provide all Ministerial briefings and internal memos generated between May 2020 and today that include mention of the proposed transitional housing development at Wood Street Wainuiomata. If this part of the request will take longer, please respond to the earlier parts first and don't let this hold up the response.
 - *a*) Kāinga Ora has provided a range of advice to the Minister of Housing, Hon Dr Megan Woods, about Wood Street since May 2020. Two updates have been included in the Weekly Report to her office. I provide those updates as excerpts here:
 - Excerpt from Weekly Report for the period ending 19 June 2020

Wood Street, Wainuiomata - Transitional Housing Village

Kāinga Ora- Homes and Communities is currently working through options for a mixed model of permanent public housing and transitional housing. We are working with LINZ on options to purchase the land, and are engaging with Port Nicolson Block Settlement Trust.

As plans progress we will be in touch with the community. We have had ongoing conversations with stakeholders and members of the community, and in late May 2020 we sent a letter to stakeholders and the community advising that we were still working through these options, and that we will share these revised plans based on community feedback ahead of lodging consent.

When we are in a position to share these plans, we will look at options for the best way to share these.

Wood Street update

Kāinga Ora has been in discussions with the Port Nicholson Block Settlement Trust regarding the Wood Street site. During the discussions the Trust floated a number of ideas, each proving not to be workable for a variety of reasons, including potential purchase or lease terms and timing.

Discussions concluded last week with an agreement that Kāinga Ora and the Trust would not work together on Wood Street, and Kāinga Ora could move to purchase Wood Street and develop it by itself. Kāinga Ora and the Trust would continue to explore development and partnership opportunities elsewhere in their area of interest in Wellington and Hutt Valley.

Te Arawhiti and Land Information New Zealand have been advised that discussions with the Trust have concluded and Kāinga Ora will start the purchase/transfer process. On 12 August 2021, the engagement team will meet and plan updating the community.*

*NB: Since the above item was provided to the Minister, Te Arawhiti has advised that it intends to consult with other iwi who may have an interest in the land at Wood Street. This consultation will need to be completed before Kāinga Ora can start the purchase/transfer process.

- b) Some briefings have been delivered verbally, on an informal basis. No record has been kept of these briefings, which I therefore decline to provide under section 18(e) of the OIA as the information does not exist.
- c) Kāinga Ora has also provided the Minister with advice and draft answers to 31 Written Parliamentary Questions (WPQs) about Wood Street since May 2020. These are listed below. I am withholding the background advice and draft answers to the WPQs which were provided to the Minister under section 9(2)(f)(iv) of the OIA to protect the confidential advice of officials. With regard to the public interest in the withheld information, I consider that this is met by the publication of the answers.

d) On 30 September 2021, the attached Ad Hoc Briefing was provided to the Minister about Wood Street. Information has been withheld under section 9(2)(g)(i) of the OIA to protect the free and frank advice of officials, and section 9(2)(a) of the OIA on grounds of privacy. I do not consider that the public interest in this information outweighs the need to withhold it.

 - Hon Dr Megan Woods (Minister of Housing) replied: Kāinga Ora Homes and Communities advises me that, based on community feedback, officials are continuing to work through options for purchasing the land, and a mixed model of permanent public housing and transitional housing. This is taking some time to work through, however, Kāinga Ora plans to provide an update on progress to stakeholders and the community soon. Kāinga Ora will also share the revised plans with the community before lodging Resource Consent.

 - Hon Dr Megan Woods (Minister of Housing) replied: Following discussions with Land Information New Zealand and Te Arawhiti (Office for Māori Crown Relations), Kāinga Ora contacted the Port Nicholson Block Settlement Trust to reach an agreement with PNBST on Wood Street before the site's classification as a deferred settlement property was removed from its title.
