I write in response to your request dated 23/09/2024, for information under the Official Information Act (1982):

"I read in a NZ Herald article that on September 18 it was confirmed that 53 Kāinga Ora developments which were under assessment in Rotorua were proceeding, I was wondering if you had a list of the developments that are proceeding, still under assessment or cancelled after this assessment process".

Kāinga Ora is delivering social housing targets as directed in the Letter of Expectation from the Minister of Housing.

The figure of 53 projects under assessment is based on the projects being assessed as at 31 August 2024.

Table 1 below provides a list of developments in the Rotorua Lakes Council Territorial Local Authority that have since been delivered, are approved and proceeding to contract, contracted and under construction, still under assessment or not currently proceeding following assessment, as at 30 September 2024.

As at 30 September 2024, there were 22 projects contracted or under construction; three were delivered in September 2024; and 29 projects have been approved to proceed to contract. These projects will deliver over 380 new homes in Rotorua. Ten projects were under review as at 30 September 2024, and were being assessed for value for money. As decisions on individual projects are made, our usual engagement and procurement processes will proceed.

Two projects are not proceeding at this time. The assessment process is ongoing, and projects that are currently not proceeding may be reassessed later.

While these projects have been put through our assessment process and a decision has been made to not progress with them as originally planned, it is important to note this doesn't mean development on these sites will never proceed.

The projects may need to be re-designed to achieve best value for money or other options for the site will be considered, including using the home as is, renovating the home, or selling an older home and replacing it with a new home elsewhere.
