On 15 September 2025 I wrote to you advising that Kāinga Ora – Homes and Communities required more time to respond to this part of your 28 July request under the Official Information Act 1982 (the Act):

- the list of vacant land parcels slated for sale, their valuations, and any conditions placed on future development (e.g., must be used for housing).

A list of vacant land that Kāinga Ora had made the decision to divest as at 31 August 2025 follows as Appendix One. The valuations are withheld under section 9(2)(i) of the Act, to enable a Minister of the Crown or any public service agency or organisation holding the information to carry out, without prejudice or disadvantage, commercial activities.

As announced in June, Kāinga Ora completed a review of its vacant land holdings earlier this year to determine what land it made sense to hold onto for the commercially responsible development of social housing and what land was best to be released for others to develop. As a result of that review, Kāinga Ora plans to sell about one-fifth (roughly 36 hectares) of the vacant land it owns because it is no longer needed for either social housing projects or for urban development work. Selling this land opens opportunities for others to increase the country's housing supply. The sale of each parcel of land is still subject to business case approval.

We want to get the best price possible for the land so the exact timing of when we will list sites for sale will depend on market conditions and other variables that could impact on price. For example, with some larger sites we may look to subdivide before we sell to maximise their value.

Most of the land earmarked for sale is zoned for housing. Where land is not already zoned for housing, we might look to get it rezoned before putting it on the market.

Like any developer, we are continually reviewing the land we own to see if it still fit for purpose and as such, it is expected that the divestment of sites will be an ongoing process. It is likely that further sites will be added to our divestment programme in the future.
