Vaka Tautua Community Event Launch Te Motu Way	
<ul style="list-style-type: none">Vaka Tautua is a “For Pacific by Pacific” community organisation that delivers a wide range of services to older people and people with disabilities.Kāinga Ora has a communal space at a development in Te Motu Way, Mangere and it was identified that elderly customers in the area would benefit from more wrap-around support.Kāinga Ora and Vaka Tautua have agreed to partner on a three month pilot for these customers. The Te Motu Community room services Te Motu Way, Clare Place, Ceasar Place and Roy Douglas Place, representing a total of 68 two-bedroom dwellings, housing our 55 year-old plus customers who are primarily Māori and Pasifika.Vaka Tautua and Kāinga Ora, launched this programme on 4 July 2024 to introduce the concept to customers and confirm which programmes they would most benefit from. Initial feedback has been that financial literacy training and recreational programmes would be highly valued.
