Sharing Te Mātāwai experiences		
<ul style="list-style-type: none"> On 23 July 2024 our Te Mātāwai team hosted s 9(2)(a) Common Ground Queensland and s 9(2)(a) Micah Projects. Common Ground Queensland is a registered community housing provider that offers long term and affordable supported housing for people who have experienced chronic homelessness. Micah Projects is a Brisbane based, not-for-profit, organisation which provides support and advocacy for people experiencing housing stress and homelessness. Both organisations contributed extensive insights and advice when Kāinga Ora was planning the development of Te Mātāwai. s 9(2)(a) were very complimentary of the design and amenity at Te Mātāwai and asked a number of questions about the collaboration and partnership with Ngāti Whātua Ōrākei. They were also interested to understand the referral process and availability of mental health services for customers living in Te Mātāwai.
