

2. Updates for Hon Chris Bishop, Minister of Housing

Healthy Homes Update

- Under the Residential Tenancies (Healthy Homes Standards) Regulations 2019, all tenanted Kāinga Ora homes are required to meet the Healthy Homes Standards by 1 July 2024.
- The Kāinga Ora compliance numbers at 1 July are:
 - 67,672 Kāinga Ora home are tenanted and are required to comply
 - o 99.80 percent (67,535 hom s) met Healthy Homes Standards requirements
 - o 0.1 percent (48 hom s) had work in progress to meet the standards
 - 0.1 percent (89 home) remain to be assessed. These are homes that were exempt from meeting the Standards due to planned redevelopment, which is no longer proceeding as we now work to align our build and redevelopment programme with the Ministry of Housing and Urban Development's Public Housing Plan.
- Of the homes in progress or yet to be assessed, we are resolving access challenges in 37 of them. These homes house vulnerable tenants with complex needs and underlying issues, including mental health challenges. We are actively working with these tenants and have utilised options available to us under the Residential Tenancies Act to enable the necessary work. The tenants have been issued with notices under section 53B of the Act, requiring relocation to another property so Healthy Homes work can be completed, and possession order applications have been lodged with the Tenancy Tribunal for tenants who have not allowed access at the end of the 90-day notice period.
- Kāinga Ora is working to complete remaining homes as quickly as possible.
